## PREVIOUS CONFERENCES

#### 7<sup>th</sup> Annual Conference (2024)

The seventh annual conference on Energy Arbitration and Dispute Resolution in the Middle East and Africa brought together legal practitioners, industry leaders, government representatives, and academics from around the world. Hosted at Herbert Smith Freehills in London, the conference featured keynote addresses from leading figures in international arbitration, including Funke Adekoya (Senior Advocate of Nigeria and expert in energy and construction disputes) and Sarah Malik (award-winning arbitration and litigation specialist). Over the course of two days, the event covered key issues such as the evolving landscape of energy disputes, the role of arbitration in the energy transition, and the impact of geopolitical developments on dispute resolution in the region. With contributions from over thirty high-profile speakers, the conference provided a platform for insightful discussions on procedural advancements, dispute avoidance strategies, and cross-border legal challenges. The event was supported by prominent sponsors, including Grant Thornton, the International Centre for Dispute Resolution (ICDR), and Herbert Smith Freehills







### 6<sup>th</sup> Annual Conference (2023)

The sixth annual conference on Energy Arbitration and Dispute Resolution in the Middle East and Africa was attended by over one hundred in-person attendees from across the world and included representatives from government, legal practice, industry, diplomacy and academia. Keynote addresses were delivered by Lise Boseman (Executive Director of the International Council for Commercial Arbitration (ICCA) and Senior Legal Counsel at the Permanent Court of Arbitration (PCA)) and Craig Tevendale (Partner and Head of Energy Group UK at Herbert Smith Freehills). This was alongside participation from over thirty high-profile speakers. Some of the key themes across the conference's varied programme encompassed the ongoing implications of the Energy Transition, including infrastructure development and related transboundary issues. The event also assessed the success of renewed efforts by investors to implement Dispute Avoidance measures.







#### 5<sup>th</sup> Annual Conference (2022)

The fifth edition of the conference was attended by over one hundred in-person and virtual attendees from across the world. Leading voices in the fields of international law, international relations and energy law discussed the legal, geopolitical, economic and international security dimensions of energy diusputes in the region, as well as offering practical guidance for their successful resolution. Keynote addresses were delivered by Lord Angus Glennie (Appeal Judge at the Dubai International Financial Centre courts) and Diamana Diawara (Africa Regional Director at the ICC), alongside participation from over 20 high- profile speakers from international arbitral institutions, leading legal practices and specialist academic centres.

A key theme across the conference's varied programme included the possible economic and political challenges created by the twin need across much of Africa and the Middle East for sectoral diversification and an energy transition.









#### 4<sup>th</sup> Annual Conference (2019)

The conference in 2019 focused on a broad range of technical, economic and diplomatic factors that affect Dispute Resolution in the Middle East and Africa. The conference again examined the impact of oil price variations and regional security issues across the continent and brought together a variety of participants including: academics, arbitrators, mediators, business professionals, corporate counsel, expert witnesses, government representatives, legal directors and practitioners, management consultants and many more.

This facilitated a timely dialogue and exploration of the ever-changing nature of energy law and energy arbitration, taking into account the constant fluctuations in the international sphere.







### 3<sup>rd</sup> Annual Conference (2018)

In its third year, the Annual Conference focused on a broad range of technical, economic and diplomatic factors that affect Dispute Resolution in the Middle East and Africa. Senior Advocate of Nigeria, Funke Adekoya, delivered the keynote speech during the Conference.

The host – the London Centre of International Law Practice (LCILP) – invited senior officials and representatives from the energy industry and from government departments and regulatory bodies, as well as senior practitioners from the legal field to participate in an enriching and focused discussion surrounding energy arbitration. This included: The Impact of the One Belt One Road (OBOR) initiative on the Middle East and Africa, Energy Poverty in energy rich countries and regional foci including on East Africa. This allowed attendees to engage in a debate on how these issues affect parties involved in disputes, and what strategies can be put in place to manage the risks associated with international energy contracts.







#### 2<sup>nd</sup> Annual Conference (2017)

The second Annual Conference on Energy Arbitration and Dispute Resolution in the Middle East and Africa was hosted by the London Centre of International Law Practice (LCILP) and one of the world's leading arbitration practitioners, Gary Born of Wilmer Hale, delivered the keynote address. During the Conference, experts from around the world engaged with Energy and Arbitration lawyers and business leaders and diplomats involved in the energy industry to discuss the best practice solutions in resolving issues arising from contractual and treaty obligations, focusing on the Middle East, Africa and the Eastern Mediterranean.

The Conference examined then-current geopolitical and macroeconomic issues affecting the energy industry in the focus regions, and questioned whether the state of dispute resolution in the energy industry was fit for purpose and analysed trends and technologies likely to impact the practice of arbitration and dispute resolution in the future.







#### 1<sup>st</sup> Annual Conference (2016)


This Conference was hosted by the London Centre of International Law Practice (LCILP) and co-organised by the Saudi Law Training Centre (SLTC). The Conference addressed the challenges in the then-current context marked by political instability and a drop in oil prices that is currently affecting the energy market in the Middle East and Africa.

Some of the main themes throughout the Conference and Workshops included, amongst others, a global insight into energy arbitration and dispute resolution, energy arbitration in the regional context of Africa and the Middle East and technical legal considerations in energy disputes. Other relevant topics included investor protection, renewable energy and state actors, varying case studies on energy related disputes and more.
